4B. Outreach as Equity: Early Intervention for High-Risk Covid

Collaboration between public health and medical agencies proved essential to limiting the severity of COVID-19 in a rural, Indigenous community. Frequent, in-person evaluations of people at risk for severe COVID-19 limited community-wide mortality were supported by an integrated, data-driven response that adapted real-time data to identify patients for evaluation and treatment.

Rural COVID-19 Resiliency: Addressing High-Risk, Underserved Populations

Facilitated by health department staff, a Covid-19 Health Equity Coalition awarded nearly \$200,000 in rural carve-out funding to support resiliency in Kittitas County, a rural county with 45% of its population in unincorporated areas. Projects include peer support for the Latinx community and cultural opportunities for Native American/Alaskan Native families.

4C. Caring with Pride: Health for Rural LGBTQ+ Communities (available on demand 5.17.23)
